2. **Procurement** shall be made in accordance with Punjab Procurement Rules, 2014 (PPR, 2014), **on a Single-Stage Two Envelopes basis.**

5. **Bids shall be submitted electronically** on the e-Punjab Acquisition and Disposal System (E-PADS) **by 11th March, 2026 at 11:00 a.m.**, which will be opened on the same day at **11:30 a.m** through e-PADS, in front of the representatives of the bidders who choose to attend the opening at the office address of the Procuring Agency.
6. The provisions in the Instructions to Bidders and in the General Conditions of Contract are included and are read with the provisions of the Bidding Documents.
7. **Bid Security (3% of the estimated cost)** in the shape of CDR/DD/Banker's Cheque in the name of Director General, PDMA shall be submitted in hard copies of the financial instruments (in addition to the soft copy uploaded with the bid) on or before **11.03.2026 at 11:00 a.m.** at PDMA office 152-B, New Muslim Town, Lahore.
8. Bidders are requested to give their best and final prices as no negotiations are expected.
9. Samples of all Items are required to be submitted at PDMA offices before the closing date of bid. In case of imported items, if sample is not available, detailed technical brochure with specification and design will be submitted.
10. Taxes will be deducted as per applicable government rules. NTN, PRA and Sales Tax registration certificates must be provided.
