Provincial Disaster Management Authority, (PDMA) Punjab, intends to prequalify well reputed, Sales Tax/Income Tax registered Authorized Dealers/ Distributors/ wholesalers/ stockiest/General Order Suppliers/ vendors for procurement of Standardized Food Hampers on need basis during Financial Year 2024-2025 (w.e.f. 01.07.2024 to 30.06.2025).

1. **Procurement** shall be made in accordance with Punjab Procurement Regulatory Authority, Rules-2014, on **Single Stage Two Envelope basis**.

5. Sealed Bid (Both Technical & Financial Proposals), complete in all respect must reach/ be dropped in the Tender Box, placed at reception of the PDMA office, 5th floor, Cricket House 20/A, Shadman-II, Lahore on or before the last date of submission i.e. **05.03.2024 at 02:00 pm**.
6. Bids which are incomplete, not sealed, late or submitted by other than specified manner shall be returned un-opened.
