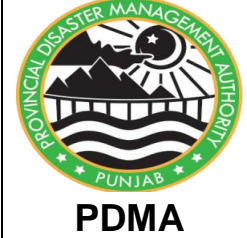

- Procurement** shall be made in accordance with Punjab Procurement Regulatory Authority, Rules-2014, **on Single Stage Two Envelope basis.**
- Prequalification/Tender Documents** along with Qualification, Evaluation Criteria are available at PPRA's website that can be downloaded from there. The same can also be purchased on payment of Rs.2,000/- from PDMA office.
- Bid Security** worth 3% of the estimated cost of each item in the shape of CDR/DD/Banker's Cheque in the name of Director General, PDMA must accompany with the Technical Bid.
- Sample** of each item (returnable), as per standardized specifications shall be deposited with Incharge PDMA Warehouse, Harbanspura near Jallo Park, Lahore or within office hours before closing date & time. Technical proposal must accompany with the sample deposit receipt.
- Sealed Bid** Both Technical & Financial Proposals completed in all respect must reach/ be dropped in the Tender Box placed at reception of the PDMA office, on or before the last date of submission i.e. **17.04.2024 at 02:00 pm.** Unsealed/incomplete bids will return unopened.
- Technical Bids** shall be opened on the same date at **02:30 pm** after 30 minutes after the closing time in the presence of interested authorized representatives of the bidders.
- Bidder can participate in single or more item(s)/Lot(s) but will submit this bid(s) for each lot separately in sealed envelopes marked with Company name, procurement Lot, Technical or Financial bid.
- The Purchaser reserves the right to reject all bids as per Rule 35 of the PPRA Rules 2014 amended up to date.
