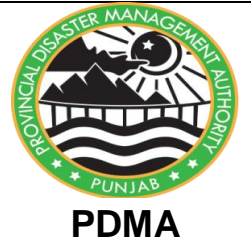

Bidders/contractors shall submit hard copies of the financial instruments (in addition to the soft copy submitted with the bid) as bid security on or before **26.05.2025 at 11:00 a.m.** at PDMA Office 152-B, New Muslim Town, Lahore.
- In case the date of opening or last date of submission is declared as a public holiday by the Government or non-working day due to any reason, the next official working day shall be deemed to be the date of submission and opening of tenders accordingly.
- PDMA will not be responsible for any cost or expense incurred by Bidders regarding the preparation or delivery or electronic submission of Bids.
